On approving contract on rendering services of technological supervision for the period of 01.02.2013 – 31.03.2013 concluded by "FGC UES" JSC and "Kubanenergo" JSC as transaction of interest

In accordance with paragraph 1 article 81 of Federal law No.208-FZ dated 26.12.1995 "On joint stock company" (hereafter – Federal law "On joint stock

company") the transaction concluded by "FGC UES" JSC and "Kubanenergo" JSC is considered as transaction of interest for:

- 1. Company's shareholder Holding IDGC JSC that holds more than 20% of voting shares and which affiliated persons are:
 - members of the BoD: Fyodorov D.V., Kravchenko V.M., that occupy positions in management bodies of "FGC UES" JSC (members of the BoD) which is the party of transaction;
 - of "FGC UES" JSC is the party of transaction
